# **Leadership Criteria and Qualifications/Responsibilities**

The Treasurer/Chief Financial Officer (CFO) is responsible for overseeing the entire financial operations of the organization, the accuracy and timeliness of all state and federal reporting, and the development of the annual district operating budget and the Financial Forecast. The CFO is an active participant on the senior leadership team and will provide leadership for the district in areas including finance, strategic planning, program development, and will be a resource for business and human resource functions. The applicant must possess a valid Ohio Treasurer's license. Successful experience as a School Treasurer is preferred. The CFO must maintain integrity and high standards of ethics in all matters. The successful candidate will demonstrate the following financial leadership characteristics:

- Proven ability to work with others a team player
- Strong financial and detail-oriented reporting skills
- Ability to facilitate educational discussions/decisions through a financial lens
- Demonstrated excellent interpersonal and effective communication skills
- Demonstrated knowledge of state and local funding issues, Ohio laws, and regulations of public schools
- Experience in effective process management and organizational skills
- Leadership skills for staff and various finance committees
- Experience with and understanding of operating software and procedures
- Expertise in developing, communicating and managing business office procedures

#### **Compensation and Terms of Employment**

The Board intends to offer the successful candidate a contract, as per law. The base salary range is expected to be \$135,000 to \$150,000 but is negotiable and commensurate with experience and qualifications. A highly competitive fringe benefit package is negotiable including SERS pick up, Medicare Tax pick up, comprehensive medical insurance, generous vacation terms and annuity compensation. Relocation assistance will be offered to candidates from outside the area who agree to live in the District.

### The District

The Olmsted Falls City School District encompasses approximately 16 square miles, primarily in Cuyahoga County, with a small portion in Lorain County. The District serves about 26,000 people and is located approximately 15 miles southwest of downtown Cleveland. The District primarily consists of Olmsted Township and the City of Olmsted Falls, with small sections in the cities of Berea and North Olmsted, as well as Columbia Township. The District was formed in 1916 by the consolidation of two separate districts servicing the City and the Township.

The district serves as the largest employer in the local area, while residents have employment opportunities throughout Cuyahoga County and nearby counties in the Cleveland metro area.

Diversified transportation options serve the District's general area. The Ohio Turnpike bisects the District with two entrances in proximity. Interstate 480 is just north of the District, and Interstate 71 is just to the east. The three highways offer easy access to other interstate highways in the Cleveland Metropolitan area, including I-77, I-90, and I-271. Cleveland Hopkins International Airport is located within 15 minutes of the District.

Overall enrollment has been relatively stable with periods of slight increases and decreases over the past decade. The number of average daily members (ADM) was 3,482 in 2020 and is anticipated to be 3,480 this school year. The district does not accept open enrollment students.

The most recent levy the district voters approved was an 8.9 mill current expense levy in 2020. All district levies have been approved for a continuing period of time.

The District issued \$4.2 million in COPS in June 2025 for the construction of a new administration building.
